* Clock stops for all technical foul shots

* Clock will stop on every whistle last 2 minutes of each half

* 3 minute half-time

* 3 full time-outs per game

* All other PIAA rules in effect

* If you are ejected from a game, you must sit out the following game. Two ejections in one season will put you out for the remainder of the games. No refunds will be given.

* If you must cancel a game for any reason, 24-hour notice is required. Games canceled after the required cancellation time may not be able to be made up.
